£180 million funding

We have £180 million of funding from the UK and Scottish governments to co-invest in projects that take new technologies from early stage concept right through to deployment. Matched funding from industry is required to create collaborative, co-funding partnerships.

Directed projects

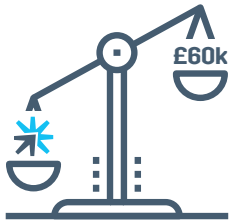
Directed projects involve a small number of companies, focused on common objectives, with individual funding and intellectual property arrangements. Directed project participants can receive automatic solution centre membership.

Portfolio projects

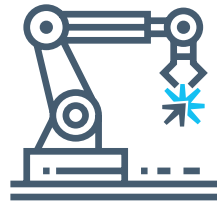

Get Leverage

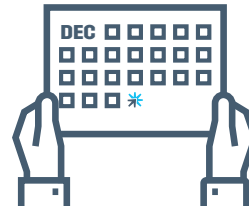
Members can take advantage of our in-kind funding model

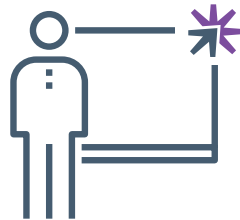

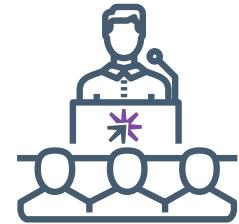
